**Entry Fee:** The NRA Registration Fee for Registered Matches of \$5.50 is included in fees listed below. Match entry fees are as follows; 1 Match Entered = \$15.00, 2 Matches Entered = \$25.00, 3 Matches Entered = \$35.00, Practice with Awards Only = \$30.00, Practice with Score sent to NRA = \$10.00, Practice Only = \$5.00. Junior fee discount = \$10.00 if entered in the complete 2700 match.

**Rules & Classifications:** All current NRA rules will apply throughout the match. The Match is open to anyone. NRA membership is optional but suggested. Classification will be as follows; High Master, Master, Expert, Sharpshooter, Marksman, and Unclassified.

**Awards:** There must be at least 3 competitors in a class before there can be an Award for that class. If there are less than the required 3 competitors in a class they will be moved to the next higher class. There will be an additional Award for each additional 4 competitors in a class. If there are less than the required 3 competitors in the High Master class, in they will be eligible for the Open Award only. If there are less than the required 3 competitors in the unclassified class, they will be assigned to the Master class. Awards will be cash and are based on a minimum of 50% return of the match entry fee after expenses.
